Early Intervention provides developmental supports and services to children birth through three years of age, who have special developmental needs. TRE provides services such as speech therapy and physical or occupational therapy. Services are provided at no cost to families. In 2017, TRE served approximately 1,908 infants and toddlers in EI. 30% of the children in this program will "graduate" and will not need special supports for the rest of their lives.

4b (Code: ) (Expenses \$ 2,117,657. including grants of \$ ) (Revenue \$ 2,241,080.) Supported Living Services is a program for adults with developmental disabilities that enable a person to remain in control of his or her own living arrangements and be included in their community. The participant chooses where they live, work, and play; who supports them and what type of supports they need. Number of consumers served was 788.

4c (Code: ) (Expenses \$ 6,626,973. including grants of \$ ) (Revenue \$ 6,349,991.) Community Coordination, or case management as it is commonly called, is an individually centered, family and community-focused service in which programs and resources are coordinated to enhance people's lives and build independence. Community Coordinators navigate an array of supports that are available for individuals, how to become eligible, and how to request and access services. The goal of Community Coordination is to assure that necessary services are provided effectively and efficiently through establishing meaningful relationships with each individual, their family, and the community in which they live, work, and play. Number of consumers served was 1,824.
