Federal Executive Orders and Changes

Significant and quick activity continues at the federal level. Currently, Medicaid services for individuals with disabilities have not been affected. All systems and services remain in place in Colorado's LTSS system. Provider billing systems have also been addressed to ensure providers are able to bill for services. Current efforts locally are focused on providing resources for up-to-date information and toolkits to support businesses and people receiving services. We have included some of these below.

HCPF Updates

- HCPF Terminates MedRide's Contract HCPF terminated MedRide's contract effective February 7, 2025 and as a result MedRide is no longer allowed to provide NEMT services for Colorado Medicaid.
 Medicaid recipients are encouraged to provide a new provider from this list Non-Emergent Medical Transportation (NEMT) Service Areas | Department of Health Care Policy and Financing. Members can also call 800-221-3943 to get help finding an NEMT provider.
- Medicaid Buy-In Program Premium Payments Monthly premium payments for the Medicaid Buy-In Program will start again in May, 2025. Initial notifications have been sent to recipients. Payments, based on monthly income, will need to be paid in order for a Member to maintain Medicaid under this program. A premium letter will be sent in April to recipients stating the amount owed each month. First month payment will be due by May 15, 2025. Payments can be made online or with a check or money order.

What Members Should Know

- Colorado Medicaid has not been impacted by federal Executive Orders and Members' services remain in place.
- If a Member is told that their Medicaid is on hold, they should reach out to their TRE Service
 Coordinator to determine the reason. While the issue may be a misunderstanding created by recent
 federal funding freezes, it is also possible it has been placed on hold for a different reason that needs
 resolution.
- If someone calls a Member claiming to be from TRE and asks for the Member's maiden name and social security number, the Member should not provide this. TRE will never ask for a maiden name and will only request a social security number during the intake process.
- Anyone receiving Medicaid through the Medicaid Buy-In Program should expect a notification of a
 premium payment for this benefit. They will receive notification in the very near future of this as well
 as a statement of the amount owed in April. The first month payment, based on income, will be due
 May 15, 2025.

What The Acronyms Mean

- Acronym Guide: Office Of Community Living Acronym Glossary | Colorado Department of Health Care
 Policy & Financing
- Member = person in services
- CCM = Care and Case Management system (statewide Member health record). This replaced the Benefits Utilization System (BUS)
- HCPF = Health Care Policy and Financing
- CMA = Case Management Agencies. Formerly CCBs and SEPs.
- CMRD = Case Management Redesign
- DSA = Direct Service Area. This is how CMRD designated CMAs. TRE works with both DSA 11 (El Paso, Park, and Teller Counties) and DSA 12 (Pueblo County).
- LTSS = Long Term Services and Supports. Also known as HCBS (Home and Community Based Services) or LTC (Long Term Care).
- OCL = Office of Community Living
